

- You must have completed *equivalent* modules to BUU3353 Financial Accounting I AND BUU33532 Financial Accounting II and for semester 2 the part 1 equivalent

## BUU33750 / BUU33620 & BUU44700 Sustainable Finance

- You must have completed an equivalent module to BUU22550 Introduction to Finance

# Tutorials


